I hereby acknowledge and agree that I have carefully read this Waiver and Release agreement, that I fully understand same, and that I am freely and voluntarily executing same. [____]

By signing this release I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that I may sustain to my person, other person(s) in my custody, pets, or animals, occurring as a result of the services (i.e., pet waste removal and related services) provided by Releasor. I have been given the opportunity to seek independent legal advice prior to signing this Waiver and Release agreement. [____]

I understand that the Releasee(s) would not perform any pet waste removal or related services upon my property unless I sign this Waiver and Release agreement. [____]

I understand that this Waiver and Release agreement is binding on me, my spouse, my heirs, my executors, administrators, personal representatives and assigns. [____]

I acknowledge that my pets/animals do not have any physical limitations, medical ailments, physical or mental disabilities that should/would limit or prevent the Releasees from participating in the above mentioned activity, and, if required, will obtain a medical examination and clearance. [____]

This release contains the entire agreement between the parties to this release and the terms of this release are contractual and not a mere recital. [____] [Contract is used as a term of art here. Each job is, in and of itself, a single contract. The Releasor is not required to enter into any long-term contract with the Releasee].

This Waiver and Release Agreement will be construed in accordance with and governed by the laws of the State of Louisiana, and it is acknowledged by the Releasor to be as broad and inclusive as permitted by the laws of this jurisdiction. [____]
